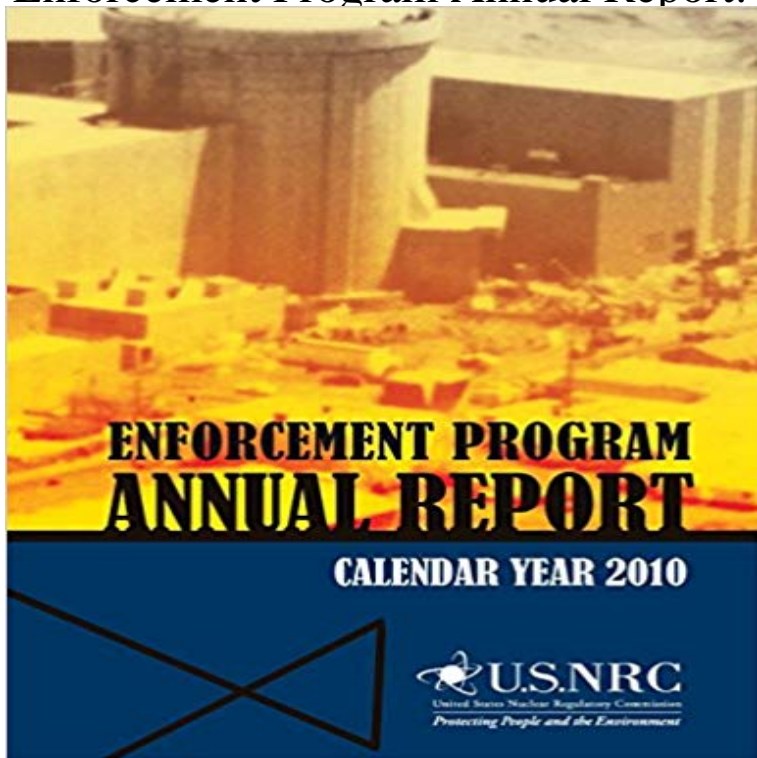


# Enforcement Program Annual Report: Calendar Year 2010
